PBSC History & Mission

The Palm Beach Sailing Club was founded in 1966. Our beautiful 1920's era clubhouse and two-story boathouse accent our waterfront property, which was once a private residence. The founders purchased this property with the goal of promoting sailing, training, racing, cruising and the camaraderie that sailors share throughout the world.

The objective of the club shall be to develop, encourage and stimulate interest in sailing in the Palm Beach County area, to promote fellowship and camaraderie among local and visiting sailors, and to offer sailing education and training to members and others.

Organization & Membership Process

We are a private organization, owned by its members, and governed by an annually elected Board of Directors and Flag Officers. All members must apply for membership and be accepted by the Board. Membership is not restricted by age, gender, creed, race, religion, national origin or sexual orientation.

Applicants have the option to pay annual membership in full or enlist in our Monthly Payment Plan, in which we charge your card automatically for a monthly service fee of \$5.

Club Activities & Offerings

Adult Sail Training

Small boat courses offered include Private Adult Sailing Lessons and ASA 101 Basic Keelboat and ASA 103 Basic Coastal Cruising Certifications. Additional courses are offered based on student and instructor availability.

Youth Sailing Program

Seasonal camps take place during Summer, Winter break and Spring break. Our Youth Sailing Team runs from September through December and January through May with weekly practices and monthly regattas. We also offer private lessons upon request. *Members receive discount.

Racing and Regattas

We sponsor large and small boat regattas, both offshore and in the Intracoastal Waterway including Florida Laser Masters, Washington's Day Regatta, Blue Regatta for Autism, Fred Thomas Memorial Race and Turkey Day Race. We also have Wet Wednesday small boat races weekly during the summer and Sunday Funday small boat racing on the last Sunday of each month.

Club Boat Usage & Boat Storage

Club sailboats are available for use by members following a satisfactory checkout by our sailing director. If you are a boat owner, full membership includes usage of our docks and ramps for launching. Small boat storage is also available for an additional annual fee.

Social Events

We open our bar Wednesday and Friday evenings and Sunday afternoons and serve dinner from our "Mariners Grill" on Wednesdays and Fridays. We also host a monthly Sunday Funday that includes small boat races and boat rides, pot luck lunch, lawn games, music and cash bar. Other events may include barbeques, pot lucks, Chalk Talks, wine and food pairings, raft-ups and more. Members also have the ability to invite and entertain guests at the Club.
